LOCATION

The property is situated in Clifton, Bristol in a prime location, with high footfall, just off The Durdham Downs.

DESCRIPTION

This is an exceptional opportunity to acquire a fully fitted café in Clifton with a large bright glass frontage. To the ground floor the property has an open plan seating area with a bar to the front, further sales, a kitchen preparation space to the rear, a store and a single W.C. The property carries painted plastered walls, a suspended ceiling with a mix of pendant lighting and wall mounted spotlight throughout and laminate effect floors.

At the rear of the property there is access to the basement which has a fully fitted commercial kitchen with extraction. There is a single W.C. and bin stores to the rear. In terms of services, the property has air conditioning units' electricity and water. There may formerly have been gas in place though the property does not currently utilise a gas supply. The property has further been fitted with a wall mounted electric fire.

TENURE

The occupational lease is dates 29th March 2023 and runs for a term of 5 years. The passing rent is £16,850 per annum, and the rent is paid monthly in advance. There is a rent review on 29th March 2026. The lease has been contracted within the provisions of the Landlord and Tenant Act 1954.
